Overview

Many states' regulations require producers representing certain types of products, such as annuities or long-term care insurance, to take product-specific education courses. Insurers are obligated under these regulations to be able to provide proof that producers representing their products have completed the required education.

In Producer Manager, a combination of verified education coursework and active, relevant LOA can fulfill the requirements of a **credential program** and earn a producer an **education credential**. An active **education credential** can serve as visual or systemic verification that a producer currently fulfills the basic requirements necessary to be eligible to represent a particular line of business in a given state.

Although you can create your own **credential programs**, Producer Manager includes numerous, predefined **credential programs** that are based on Vertafore's interpretation of the statutory education and license requirements for certain product lines in certain states. This document describes these predefined **credential programs**.

Important Note: Producer Manager uses a producer's state license LOA as a mechanism for determining the relevance of a credential program to the actual products the producer represents for your company. Eligibility to earn an education credential does not authorize a producer to sell a product. The licenses and LOAs required to sell a particular product should be verified independently by a user or an automated authorization system.



Credential Program Descriptions

The table below lists and provides details about each pre-defined credential program available in Producer Manager. Please note that your company's specific deployment of Producer Manager may not include all credential programs listed.

The table includes the following information:

- State: The name of the regulatory body whose regulations are interpreted in the pre-defined credential program.
- **Product Type**: The name of the product line for which producers must meet the state-specific education and license requirements of the pre-defined credential program.
- **Credential Program (Template/Vertafore Example)**: The name in Producer Manager of the pre-defined credential program. A pre-defined credential program may be one of the following types (as represented in parentheses):
 - Template: A credential program that is based on Vertafore's interpretation of state regulations concerning producer suitability to represent the given product type and that optionally may be customized to include additional, carrier-specific education course requirements. A producer must meet both the state-specific and carrier-specific requirements, if any, of the credential program in order to earn an education credential in the given state.
 - Vertafore Example: A credential program that is based solely on Vertafore's interpretation of state regulations concerning producer suitability to represent the given product type. A Vertafore Example credential program cannot be customized or modified. A producer must meet only the state-specific requirements of the credential program in order to earn an education credential in the given state.
- Credential Program Requirements: The state-specific education requirements that producers must meet in order to fulfill the credential program and be eligible to earn an education credential in the given state. A producer also must hold an active state license and active LOA related to the product type, as represented in the LOA column. Note that template-based credential programs also may include optional, carrier-specific education requirements.

Fulfillment of state-specific education requirements may be verified by the following means:

Education course completions: Verification that a producer has completed and earned credit for required education must be added to the producer's record in Producer Manager, either manually or through an automated import of course completion information from an external source, as represented in the Verification Data Source column.



- Third-party certification: An education compliance certification clearinghouse can verify a producer's completion of state-required education. A third-party certification can be added to the producer's record manually or through an automated import of a certification from an external source, as represented in the Verification Data Source column.
- Requirements Recurrence: The regularity with which a producer must fulfill the state-specific education requirements of the pre-defined credential program. A producer must fulfill the ongoing education requirements of the credential program in order to maintain an active education credential in the given state.
- **Verification Data Source**: The means by which Producer Manager may obtain verification of a producer's fulfillment of state- or carrier-specific education requirements, including the following:
 - ClearCert integration: A third-party certification of a producer's completion of state-required education can be added to a
 producer's record automatically through an import of certification information from Compliance Certification Clearinghouse, LLC
 ("ClearCert"). Available only to subscribers of ClearCert services and the Vertafore third-party certification integration service.
 - Education Bank integration: State-specific education information for a particular product type can be added to a producer's record automatically through an import of course completion records from the Vertafore Authorized Provider Network (or "CE Bank"). Available only to subscribers of the Vertafore Education Data Access service.
 - State system integration: Education information for a particular product type can be added to a producer's record automatically through an import of course completion records directly from certain "Sircon State" systems. Available only to subscribers of the Vertafore Education Data Access service.
 - Manually-entered third-party certification: A user can manually enter a third-party certification for a particular product type into a producer's record.
 - o **Manually-entered course completion information**: A user can manually enter an education course completion for a particular product type into a producer's record.
- LOA: System codes and descriptions of license lines of authority that Producer Manager uses to identify active producers who may have fulfilled the state-specific Credential Program Requirements for the given Product Type.

Note: An LOA code marked "(*Historical*)" no longer is active in Producer Manager, because it has been replaced with a different code or codes that support a state's regulatory changes. However, a specific credential program that is used to calculate producers' education credential timelines still may rely on a historical code as a part of its configuration, and so therefore the historical code may remain in the system.
